1. The Company's 2002 Share Option Scheme was adopted on 3 January 2002 and terminated on 21 September 2011. No option has been granted under this scheme.

2. The Company's 2011 Share Option Scheme was adopted on 21 September 2011. A total of 28,776,000 share options were granted on 26 November 2014 at an exercise price of HK\$1.35 per share. Upon the bonus issue of shares on 16 September 2015, adjustments were made to the outstanding share options. On 16 September 2015, the adjusted number of share options outstanding was 28,682,500 and the adjusted exercise price of each share option was HK\$1.08.
