1. The Company's 2002 Share Option Scheme was adopted on 3 January 2002 and terminated on 21
September 2011. No option has been granted under this scheme.
2. The Company's 2011 Share Option Scheme was adopted on 21 September 2011. A total of 28,776,000
share options were granted on 26 November 2014 at an exercise price of HK\$1.35 per share. Upon the
bonus issue of shares on 16 September 2015, adjustments were made to the outstanding share options on
16 September 2015; the adjusted number of share options outstanding was 28,682,500 and the adjusted
exercise price of each share option was HK\$1.08. Upon the issue of shares on 23 February 2016 as a result
of rights issue, adjustments were made to the outstanding share options on 23 February 2016; the adjusted
number of share options outstanding was 17,969,825 and the adjusted exercise price of each share option
was HK\$0.96.
